Health Report

Moving from Stress to Distress: The Impact of COVID on our Mental Health System

This presentation will be focused on how COVID-19 has impacted our communities mental health. It will focus on how this pandemic has influenced the way our system operates to provide services to those experiencing mental health challenges. The presentation will look at some of the symptom trends experienced in our communities. It will also callout fractures in the system and how we as a region and state reacted.

Bio: Timothy Hunter is a social worker who works with our regional mental health system to enhance our regional service delivery model and create a responsive system across the 10 Southeast Minnesota counties. He holds a master's degree from Augsburg College in Social Work. His education and work is focused on program development, policy and administration of human service programs.

Tim acts as our Regional Adult Mental Health Initiative Coordinator leading the program development of a regional crisis center, housing services and other initiatives. He participates in many collaborative groups across the state focused on mental health service delivery. He has been part of policy reform efforts in the state of Minnesota. He leads many multi-disciplinary groups with public and private providers aimed at educating staff and improving our system of care.

Use the Minnesota Political Campaign Refund to support your local State House and Senate candidates or your County Political party, or State Political party (Does not apply to Federal Candidates). You can give up to \$50 per person, \$100 per couple and receive your contribution back dollar for dollar. You can take advantage of this campaign refund annually. Go to https://www.revenue. State.mn.us/political-contribution-refund for more information.

The recipient political organization or candidate that receives your contribution, will send you the appropriate MN Revenue Form and a voucher verifying your contribution. You then submit the forms to the Minnesota Revenue Department and receive your contribution back usually within 3 to 6 weeks.
