#### Here's what I do as president:

The board meets in May, August, November and February. **Treasurer's Report.** Sharon Baratto handed out the SEREAM financial report and the financial report for the fall Health and Legislative Conference held on October 20. The balance in the checking account, as of November 15, was \$3307. 49.

**President's Report.** Kay Morcomb reminded us that there is an election for officers in 2022. We need candidates for the following positions: president, vice-president, newsletter editor, secretary, and historian.

**Membership.** Ben Baratto reported that there are currently 556 members. 370 have paid for 2022.

**Educator Award.** It was m/s/c that SEREAM follow the REAM guidelines for the Educator Award.

Newsletter. The next issue will be mailed in December.

REAM Conference. 114 attended the September conference in Walker, MN.

**SEREAM Conference.** 45 attended. There was an excellent speaker on mental health, flu shots were available, there was an update on our pensions, and the meeting ended with a humorist, Al Batt. Because of rising expenses, we need more attendees, or we may need to raise the registration fee.

**Spring Conference and Annual Meeting.** This will be held in Faribault. Information and registration will be in the March newsletter.

**Planning for the Fall Conference.** The Board will meet at the Homestead on March 16 at 8:45 AM.

The next Board meeting is Wednesday, February 16, 2022.

#### TRA/PERA Had an Excellent Return on Investments This Past Fiscal Year!

Jay Stoffel, Executive Director of TRA, gave an excellent power point presentation at the Annual REAM Conference in September on the TRA Trends and Comparisons. Jay gave us great news as the asset value of TRA/PERA investments went up an unbelievable 30% (Slide 18) in the fiscal year ending June 30, 2021! TRA went from underfunded liabilities needed for our future active and retired teachers' pensions at only 75.5% to 91.5% in just one year (Slide 20)!

**Slide 7.** EE stands for employee and ER for employer. TRA pays out about \$2 Billion in benefits each year to 68,000 retirees! This is a real stimulus to our State's economy!

**Slide 13.** Investment Return Future Assumptions for TRA/PERA - was set at 8.5% prior to 2018. Our Actuaries and Wall Streeters recommended reducing it to 7.5% in 2018; now they are recommending around 7% or less going forward. This reduction will be a Legislative issue in the 2022 Session. Lowering the return assumptions, increases our long term pension liabilities. REAM will be your "voice" at the table when the new assumption is debated.

**Slide 18.** Estimating 2021 Valuation Results. NOTE the first statement: 30% investment return in Fiscal Year 2021! This return also applies to PERA. This is a significant investment return engineered by the MN State Board of Investment!

**Slide 20.** This is a snapshot on July 1, 2021, of the actual Market Value of our TRA's Assets. Note: The Actuarial Accrued Liability is at \$30.8 Billion to pay projected pensions for all active and retired teachers going forward. The Asset value on our investments on July 1, was \$28.2 Billion. Therefore, our funded pension ratio went from 75.5% to 91.5% in the past year.

To TRA/PERA pension stability watchers, SLIDE 20 is VERY important. It means the 2018 Pension Bill plus the Stock Market's excellent return is stabilizing our pension. But some Legislators still want to move all new public employees from our Defined Pension Plan to a Defined Contribution Plan (401K type of pension). We must be alert!

### Health Report Infectious Disease

In 2006 I read the recently published book, <u>The Great Influenza, The Epic</u> <u>Story of the Deadliest Plague in History</u> by John M. Barry. A story worth keeping in mind so I kept the book. One quote from the book, "....up to a few decades before World War I, the practice of medicine remained .....almost unchanged from the time of Hippocrates more than two thousand years earlier. Then, in Europe first, medical science changed and finally the practice of medicine."

The author writes extensively about researchers who devoted their lives to discovering causes, treatments, and preventives of many diseases including the importance of cleanliness.

The 1918 Influenza Pandemic started in a Kansas Army Camp. In every one of our wars more soldiers died from disease than in combat. The author covers the politics and the science of dealing with influenza. The focus was war. Scientific advice was ignored. The movement of soldiers made an epidemic a pandemic.

Epidemiological research is ongoing. Much more money must be invested in vaccine manufacture and creating surge capacity, improving technology of production, and hopefully developing antiviral drugs and a vaccine to prevent all forms of influenza.

The first step in preparing for a pandemic is surveillance. The World Health Organization has prevented some epidemics from becoming a pandemic, but lacks the resources to look everywhere. Communication is important. Countries and farmers need compensation for the financial loses that telling the truth can bring. A final lesson of 1918 is that those in a position of authority must calm the public. Retain the public trust. Avoid panic by being truthful. Do not minimize the disease.

The April 2006 Minnesota Monthly interviewed Dr. Michael Osterholm, one of the world's foremost infectious disease experts, who had been warning that another pandemic is inevitable and our hospitals had no surge capacity. Businesses function 'on the edge' not maintaining vast inventories. Eighty per cent of the pharmaceutical products in the U.S. are imported. Dr. Osterholm works not in a laboratory, but in offices in the Center for Infectious Disease Research and Policy (CIDRAP) at the University of Minnesota. He works in communication and surveillance making many good predictions and warnings, but still has naysayers. He calls for our country to unite against pandemic influenza for our health and our national union.

Dr. Fauci is another person who has devoted his life to the treatment and prevention of infectious diseases. The November 2021 issue of National Graphic has excerpts from a National Geographic magazine, <u>Fauci - Expect the</u> <u>Unexpected: Ten Lessons on Truth, Service, and the Way Forward.</u> The book is drawn from interviews for a documentary film now streaming on Disney+.

We can see in real time the effects of politics and science on medicine.
