#### **SEREAM Fall Legislative and Health Conference**

October 19, 2022

The SEREAM Fall Conference was held at the Rochester International Event Center. Registration began at 8:30 AM. Coffee, juice, pastries, and also fruit were provided before the meeting. At 9:00 President Barb Hunter opened the meeting with a warm welcome. 9:05 Dr. Kent Pekel, Superintendent of Rochester Public Schools addressed the topic, "Strengthening Students' Mental Health". A Minnesota native, he became a high school teacher in his home state. His first wife had cancer and he soon found himself a single Dad with three young children. Interest in researched based practices to help young people thrive led him to develop various programs while at the University of Minnesota and at the SEARCH INSTITUTE, an international research organization. He seeks to bridge research, practice, and policy.

- 10:05 REAM President Anita Hellie spoke of the changes in education forced by the pandemic. Zoom will not go away. Consider how we can change willingly, revise local units, get younger retirees involved, get our name out, and invite community. Chuck Hellie spoke of the changes in AMBA especially changes as they offer trips again.
- 10:15 A break with more coffee and fruit, then we heard from legislative candidates Gene Pelowski and Carla Nelson. Carla expressed a need for early learning scholarships and teacher recruitment and retention. Gene was concerned about faculty and programs lost in high schools. Every high needs classes in employment skills such as electrical and carpentry. Carla was disappointed the tax bill did not pass. Gene said conference committees could have gotten the work done. Both agreed to elimination of the tax on Social Security.

After an 11:30 lunch we reconvened at 12:20 for TRA and PERA (has a new name) updates and handouts given by Jay Stoffel and Amy Strenge respectively. A 1:15 break was followed by Humor THAYER-apy by Edna Thayer.

- 1:30 Curt Hutchens has been following closely our pension plan from its establishment through the efforts of Ethel Percy Andrus. The NRTA (National Retired Teachers Association) was started in 1947. In 1954 Minnesota joined. In 1954 with the with the help of Illinois and California she started AARP. Curt is passionate about the stainability of our organization. This cannot be done on the cheap with just volunteers. We need a full time office staff, and upgraded technology and a more attractive newsletter.
- 2:15 REAM Legislative committee members, Tim Moyniham and Lonnie Duberstein had virtual meetings at the Capitol during the pandemic. They will do in person meetings again at the Capitol but could have virtual meetings involving REAM members.
- 2:45 Fatima Said told her story of becoming a Bosnian refugee. She hated to leave her country, but it was becoming too dangerous. Her son was already in Winona on a study visa and insisted, "Come to America". Fatima did not know English, was afraid of religious discrimination and wanted to stay closer to Bosnia, but came with her husband and daughter. She found many helpful people and loves America and is proud to be a citizen. She founded Project Fine to help others.

#### **SEREAM November 23 Meeting Minutes**

The meeting was called to order at 8:50am by President Barb Hunter. Members in attendance were: Barb Hunter, Kay Morcomb, Kathryn Lastine, Keith Larson, Lyle Olson, Don Leathers, Ben Baratto, and Margie White. Sharon Baratto, Don Zwach, Phoebe Praxl and Edna Thayer were absent.

Minutes were printed in the newsletter and approved as printed. Ben Baratto distributed the treasurer's report in Sharon's absence. The total Balance is \$13,332.55.

Local meeting format change was discussed. There was concern about holding meetings on Zoom versus in person or hybrid. It was noted that SE Coop has a hybrid meeting and is successful. Ben Baratto noted that 23 of Winona's members ask to be called for meeting reminders. It was also mentioned that email is not always a reliable method for meeting notifications. Democrats' control of The House and Senate is a positive and helpful for our pension support. Mike Nelson, pro-pension, was elected. Tim Moynihan will keep us up to date.

A newsletter editor is needed. There is a stipend of \$100 per newsletter. The articles do not need to be formatted. They are sent to Deb. She will have the paper newsletter printed. She will also do the web site. A vice-president is an open position as well. Please reply to Barb Hunter if interested or want more information. Don Leathers has agreed to chairing the health and legislative committees.

REAM is considering Zoom meetings and exploring executive direction. (Curt Hutchins is retiring.) A part time executive director, and a part time secretary may be hired. The executive director must be knowledgeable in pension aspects, AMBA, and will arrange meeting agendas, conduct Zoom meetings when necessary, help plan conferences and work behind the scenes on conferences. (The 2023 REAM conference will be hosted by the Willmar unit). The executive director should be a metro person, making it easy to travel to meetings. The Executive director would be hired prior to the secretary. The full REAM board will meet until decisions are made to hire an executive director. It was suggested to keep the paper newsletter.

The SEREAM Fall conference is looking into a new venue due to rising rental costs. There was a loss of \$815.30 this year. A SEREAM board member donated \$350.00, which brings our loss down to \$465.31 Food prices have gone up as well, thus registration may be increased in 2023. Several speakers were suggested. An increase in dues was also suggested and will be discussed to vote on at a later meeting. It was suggested that AARP members spouses are eligible as potential members Teachers nearing retirement need to be informed of the importance of joining REAM and how it protects pensions. Meeting with teachers in a group setting was suggested. Also suggested was informing the public that the government is not paying our pension, we, the school district, and investments fund it.

Lyle Olson made a motion to adjourn. Keith Larson seconded it. The meeting was adjourned at 10:25am. The next board meeting will be Feb. 15<sup>th</sup>.

### Fall 2022 SEREAM Legislative Report

Jay Stoffel, TRA Executive Director, and Tim Maurer, Deputy Executive Director for TRA, spoke to SEREAM members at the Health and Legislative Conference held at the International Events Center in Rochester on October 19. Assets, ratios, assumptions, accurred liabilities and benefit analysis were part of their presentation that used PowerPoint slides to drive home the point that our pensions, and the systems that support them, are in good hands. My role as SEREAM's newly-appointed Legislative Chair is to break down the above "pensionomics" into language we can all understand.

First off, financially speaking, TRA did extremely well in fiscal year 2021 with a 30% return on investment. However, as anyone with a portfolio knows, 2022 has not been quite as kind to investors. TRA's return thus far is coming in at roughly -6.4% for the fiscal year. Signs suggest that the downturn might be easing a bit, but this has been a disappointing year so far for the State Board of Investment (SBI). However, its 10 and 30-year investment returns continue to hover around 8.5%, a figure higher than the expected rate of return of 7.5%. The investors at SBI continue to outperform their colleagues in other states.

In October, Mansco Perry III retired as ED/CIO of the State Board of Investment after serving in that role since 2013. During Mr. Perry's tenure at SBI, its portfolio has increased to more than \$130 billion. His steady hand working for Minnesota's public pensions will be missed. Mr. Perry was replaced by Jill Schurtz, who previously directed the St. Paul Teachers Retirement Fund Association. Ms. Sturtz formally began her duties at SBI on October 3 of this year. All of us who support public pensions in Minnesota are confident in her abilities and extend our best wishes to her as she launches a new career as CIO of the State Board.

Directors Stoffel and Maurer also presented findings on a study, and associated issues, that directly affects actives and retirees in Minnesota. The discussion centered around the preparatory work done last session concerning possibly re-establishing the Rule of 90.

TRA received hundreds of emails from around the state inquiring about the rule. Its directors are currently reviewing the rule's history, data on its usage, trends in neighboring states and other benefit improvements including lower retirement age, higher benefit formula and other early retirement options. Many human resource directors in Minnesota public schools feel that re-establishing the Rule of 90 could be a powerful recruitment tool for attracting new teachers. It, and other related issues, promise to be a heavily discussed topics in the upcoming legislative, budget-setting session.

Finally, a tasty potpourri of interesting pension facts from the fall conference: 85% of TRA retirees live in Minnesota. Annual pension benefits in our state are at \$4.7 billion. 205,220 retirees receive a pension benefit in Minnesota. And a total of 648,494 pension members, active and retired, live in Minnesota. Those are significant numbers for our state's wellbeing.

So,... next time someone you know "raises an eyebrow" about how public pensions are a drain on Minnesota's economy, tell 'em the facts. "We worked for them, we paid for them, we deserve them." And they're GOOD for Minnesota and our fellow Minnesotans.

- 5. Honors received, Organizations, Offices held, etc.
- 6. Volunteer activities (church, community, education related, etc.)
- 7. Experience other than school related.
- 8. Service to retired and other educator groups at local, division, state and National levels.
